

**PRESBYTERY OF MIDDLE TENNESSEE  
MINUTES OF ONE HUNDRED THIRTIETH STATED MEETING  
JULY 22, 2017**

The 130th Stated Meeting of the Presbytery of Middle Tennessee was held Saturday, July 22, 2017, at East Brentwood Presbyterian Church, Brentwood. Executive Presbyter Warner Durnell and Stated Clerk Therese Howell led an orientation and time of prayer for first time commissioners. Stuart Gordon, Moderator, called the meeting to order at 9:00 a.m.

**WORSHIP**

Worship was led by The Rev. John Hilley, pastor of the host church, and The Rev. Jane Herring, pastor, Normandy Presbyterian Church. Special music was provided by Dr. Laura Kreiselmaier, piano, and Mr. Joe Ennis, percussion. The offering was collected for the Guatemala Partnership's Basico Scholarship Program. The Lord's Supper was celebrated.

**DECLARATION OF QUORUM / WELCOME BY HOST / STATEMENT OF PROCEDURES / FIRST TIME  
COMMISSIONERS / CORRESPONDING MEMBERS**

The meeting reconvened after worship, and the Moderator declared a quorum was present. Rev. Hilley welcomed commissioners to East Brentwood Presbyterian Church, and spoke briefly about the church. The Moderator reviewed procedures for the meeting, and first time commissioners to presbytery were recognized and welcomed.

The Presbytery's Mission and Operations Manual and the *Book of Order* provide for the seating of corresponding members and teaching and ruling elders with voice and those with voice and vote. Any ruling elder serving as presbytery's Moderator, Vice-Moderator, Moderator-in-Nomination, chairs of committees, members of the Administrative Committee, members of the Finance Committee, and the Moderator of Presbyterian Women, are enrolled as members of presbytery and shall have voice and vote. Ruling elders commissioned to particular pastoral service, and ruling elders who have previously served as presbytery moderator, within five years of completion of his/her term of service, are enrolled as members of presbytery with voice and vote. Any ruling elder serving as a committee representative to a particular meeting of presbytery in the absence of the chair shall have the privilege of voice and vote for that particular meeting of the presbytery. Persons certified in church service who are ruling elders shall have the privilege of voice and vote at all meetings of the presbytery, during their term of service in ministry in the presbytery of Middle Tennessee. Persons certified in church service, who are members of congregations in the Presbytery of Middle Tennessee, shall have the privilege of voice at all meetings of the presbytery during their term of service in a congregation or other ministry validated by the presbytery. Should a question arise concerning the enrollment of any person, the presbytery may resolve the matter upon the recommendation of the Permanent Judicial Commission. Corresponding members were seated without objection, and listed with the roll.

**ROLL**

The roll of commissioners, corresponding members, and visitors attending the presbytery meeting is attached (Attachment A).

**AGENDA**

The Moderator stated that the agenda for the meeting had been provided in advance to commissioners. The motion was made and seconded to set aside the standing rules to receive an additional report from the Committee on Ministry. Ruling Elder Therese Howell, Stated Clerk, presented the clerk’s report, and called attention to the report of the Hunger Action Advocate included in the Presbytery packet.

#### Beth Smith McCaw / Southminster Presbyterian Church, Nashville

The Stated Clerk received the minutes of the commission of June 11, 2017 to ordain and install Beth Smith McCaw as Pastor of the new worshipping community at Southminster Presbyterian Church, Nashville. *[Minutes to be included in permanent record]*

#### Josh Rodriguez / First Presbyterian Church, Nashville

The Stated Clerk received the minutes of the commission of June 18, 2017 to ordain and install Josh Rodriguez as Associate Pastor of First Presbyterian Church, Nashville. *[Minutes to be included in permanent record]*

#### Leslie Traylor / Hermitage Presbyterian Church

The Stated Clerk received the minutes of the commission of June 25, 2017 to install The Rev. Leslie Traylor as Pastor of Hermitage Presbyterian Church. *[Minutes to be included in permanent record]*

#### May 6, 2017 Minutes

The minutes of the 129th Stated Meeting of the Presbytery of Middle Tennessee (May 6, 2017) were presented for approval. After corrections, the minutes were approved as amended.

#### **ADMINISTRATIVE COMMITTEE REPORT**

Ruling Elder Ed Lancaster, Administrative Committee chair, presented the committee’s report.

#### Woodland Presbyterian Church

The Administrative Committee received a report from the Committee on Church Transformations related to the work of Ministry Architects at Woodland Presbyterian Church. The Administrative

Committee, in consultation with the Finance Committee, approved the continued work of Ministry Architects with Woodland Presbyterian Church from July 1-December 31 at a rate of \$2,000/month (a total of \$12,000). The effectiveness of this relationship will be reviewed by the Administrative Committee before the end of 2017 to determine appropriate next steps for 2018.

#### Woodland and Eastminster / Shared Personnel

The Administrative Committee, in consultation with the Finance Committee, subsidized the hiring of a +/- 5-hour-a-week, youth and children's worker to be shared by Woodland and Eastminster by providing a grant of \$400/month for July - December 2017 (a total of \$2,400). Upon approval by all parties, Ministry Architects would locate, train, and manage the appropriate candidate for this position and that each church would contribute approximately \$50/month to this position.

#### 2016 Audit

The Administrative Committee received a report from the presbytery's Treasurer on the 2016 audit, which will be presented at the July presbytery meeting.

#### Hispanic New Church Development

The Administrative Committee received an update and analysis of the financial position of the Hispanic New Church Development.

#### Personnel Task Force Report

Ruling Elder Elinor Foster, chair of the Personnel Task Force, presented the following report.

#### *2016 Performance Evaluations*

The Personnel Task Force finalized its 2017 performance evaluations for members of the Presbytery Staff, which include Warner Durnell (Executive Presbyter), Therese Howell (Stated Clerk), Linda Griffis (Administrative Assistant), and Barbara Howell (Hunger Action Advocate).

The Task Force submits that all staff members are meeting or exceeding job performance expectations.

Twelve month goals have been established in consultation with each staff member for each staff member, to be reviewed periodically by Warner Durnell as head of staff, and by the Task Force as a part of next year's annual staff performance evaluation.

The Task Force recommended to the Finance Committee that the Presbytery Budget continue to meet the Benefits Plan costs of the Board of Pensions for health insurance as negotiated with each staff member.

### **FINANCE COMMITTEE REPORT**

Ruling Elder Mike Ingram, Treasurer and chair of the Finance Committee, presented the committee's report.

#### Financials

Financials as of May 31, 2017, as well as an analysis of the Financials by the Treasurer, were presented for review. Mr. Ingram praised Mrs. Pat Webb, presbytery's accountant, for her work with the financials and reports.

#### Woodland Presbyterian Church

The Finance Committee, in consultation with the Administrative Committee, approved the continued work of Ministry Architects with Woodland Presbyterian Church from July 1-December 31 at a rate of \$2,000/month (a total of \$12,000). The effectiveness of this relationship will be reviewed by the Administrative Committee before the end of 2017 to determine appropriate next steps for 2018.

#### Woodland and Eastminster / Shared Personnel

The Finance Committee, in consultation with the Administrative Committee, subsidized the hiring of a +/- 5-hour-a-week, youth and children's worker to be shared by Woodland and Eastminster by providing a grant of \$400/month for July - December 2017 (a total of \$2,400). Upon approval by all

parties, Ministry Architects would locate, train, and manage the appropriate candidate for this position and that each church would contribute approximately \$50/month to this position.

#### 2016 Audit

The Finance Committee received a report from the Treasurer on the 2016 audit, which will be presented at the July presbytery meeting.

#### Hispanic New Church Development

The Finance Committee received an update and analysis of the financial position of the Hispanic New Church Development.

#### Investment Task Force

The Finance Committee received a report from the Investment Task Force. The task force transferred some investment funds to checking, and two additional transfers are anticipated, one at the end of summer, and one in December.

#### Presbytery Office Relocation

The Finance Committee reviewed the Facility use Agreement with Westminster Presbyterian Church, Nashville, for the presbytery office relocation. The three-year agreement should reduce annual office occupancy expenses for the presbytery by approximately one-half of the current costs. Build-out costs will be included over the three years of the lease.

#### 2016 Audit

The Finance Committee recommended the presbytery receive the 2016 audit. Mr. Ingram called attention to specific parts of the audit, and reported the Finance Committee had reviewed the audit. There were no questions or discussion and the recommendation to receive the 2016 audit was approved.

### **COMMITTEE ON MUTUAL SUPPORT**

The Rev. Steve Thomas, chair, Committee on Mutual Support, presented the committee's report.

#### Guatemala Partnership

Barb Hall (East Brentwood) spoke of the presbytery's partnership with the Presbytery of Peten, and Erin Rein (East Brentwood) spoke of his recent mission trip to Guatemala. David Carlson (Second) updated the presbytery on the progress of the Basico program.

NaCoMe

Ryan Moore, director of NaCoMe, spoke briefly about the camp, and invited presbyters to come to NaCoMe the day before the October Presbytery meeting to enjoy all the camp has to offer.

### **EXECUTIVE PRESBYTER'S REPORT**

Executive Presbyter Warner Durnell yielded his time on the agenda.

### **COMMITTEE ON MINISTRY**

Ruling Elder Theresa Denton, chair, Committee on Ministry, presented the committee's report.

#### First Presbyterian Church, Gallatin / Ministry Information Form

The COM approved a revised Ministry Information Form for First Presbyterian Church, Gallatin.

#### First Presbyterian Church, Franklin / Associate Pastor Nominating Committee

The COM received the following names of the Associate Pastor Nominating Committee at First Presbyterian Church, Franklin: Jennifer Godwin, Steve Lewis (chair), Jessica Queen, Bruce Tarkington (secretary), Fred Williams.

#### First Presbyterian Church, Cookeville / Pastor Nominating Committee

The COM received the following names of the Pastor Nominating Committee at First Presbyterian Church, Cookeville: Chelsea Holland, Mike Medley, Jay Robyn, Grace Anna Sine, Mark Thurman.

#### L. Kofi Adzaku

The Committee on Ministry examined The Rev. L. Kofi Adzaku, a member of the Presbytery of Grace, who has accepted a call as chaplain and CPE supervisor at St. Thomas Hospital. A copy of Rev. Adzaku's statement of faith and autobiographical statement was included with the COM's report. The

COM sustained Rev. Adzaku's examination, and approved his reception as a minister member of the Presbytery of Middle Tennessee, effective June 13, 2017.

Jane Herring / Belfast Presbyterian Church

The Committee on Ministry approved the contract for part time temporary supply (15 hours/week) between The Rev. Jane Herring and Belfast Presbyterian Church, effective July 1, 2017. Rev. Herring will continue to serve as pastor of Normandy Presbyterian Church. The COM approved the following contract terms: salary, \$28,800; cell phone (owned by and paid for by church) \$1,000, travel mileage reimbursement (estimated) \$5,000, total \$36,800; vacation, 4 weeks annually; and study leave, 2 weeks annually. Temporary housing will also be arranged on nights when service to the church and community concludes late enough to delay travel home to Nashville until the next day.

Joe Evans / First Presbyterian Church, Columbia

The Committee on Ministry approved the dissolution of the pastoral relationship between The Rev. Joe Evans and First Presbyterian Church, Columbia, effective June 30, 2017. Rev. Evans was dismissed to the Presbytery of Cherokee to accept a call.

Bo Burgener / First Presbyterian Church, Springfield

The COM approved the renewal of the interim contract between The Rev. Bo Burgener and First Presbyterian Church, Springfield.

Linda Bray

The Committee on Ministry approved the status of Honorably Retired for The Rev. Linda Bray, effective May 5, 2017.

Amelia Canon

The Committee on Ministry approved the status of Honorably Retired for The Rev. Amelia Canon, effective July 1, 2017.

Tom Patton

The Committee on Ministry approved the status of Honorably Retired for The Rev. Tom Patton, effective July 1, 2017.

James Hudnut-Beumler / Vanderbilt Divinity School

The COM renewed the validation of ministry for The Rev. Dr. James Hudnut-Beumler, Vanderbilt Divinity School.

Leonard Jordan / St. Andrews Presbyterian Church, Nashville

The Committee on Ministry renewed the commission for Ruling Elder Leonard Jordan and St. Andrews Presbyterian Church, Nashville for three years.

Ed Keith / Bethany Presbyterian Church, Ardmore, and First Presbyterian Church, Petersburg

The Committee on Ministry renewed the commission for Ruling Elder Ed Keith and Bethany Presbyterian Church, Ardmore, and First Presbyterian Church, Petersburg for one year.

Carol Tate / First Presbyterian Church, Huntsville

The COM approved the request of The Rev. Dr. Carol Tate to labor outside the bounds of the Presbytery to serve as interim pastor of First Presbyterian Church, Huntsville, pending permission to labor inside the bounds of the Presbytery of North Alabama.

Harold Dawkins / First Presbyterian Church, Fayetteville

The Committee on Ministry approved Ruling Elder Harold Dawkins to serve as part time temporary supply (27 hours/week) for First Presbyterian Church, Fayetteville for the period June 17 – August 20, 2017. The COM approved contract terms of \$6,750 for the period (\$2,250 / month).

### Non-PCUSA Pastors / COM Policy on Moderating and Sacraments

The COM discussed the issue of non-PCUSA pastors serving PCUSA churches being allowed to moderate session meetings and administer the sacraments. The COM will consider these functions separately, and address requests to celebrate the sacraments on a case-by-case basis.

#### Pat Handlson / Care Team

The Committee on Ministry appointed a new care team for Pat Handlson (Michael Davis, Ann Roberts, Stephen Yates). The COM voted to invite Mr. Handlson to its October meeting, pending successful reports and completion of the minimum twelve months of counseling.

#### Jeannie Hunter / First Presbyterian Church, Dickson, and Ellis Grove Presbyterian Church, Waverly

The COM approved the part time (10 hours / week) interim contract between The Rev. Jeannie Hunter and First Presbyterian Church, Dickson and Ellis Grove Presbyterian Church, Waverly, for the period July 1 – December 31, 2017, and approved Rev. Hunter as moderator of the sessions. The COM approved the following terms: Salary \$12.50/hour for an estimated 10 hours/week; housing \$12.50/hour for an estimated 10 hours/week; business mileage at the current 2017 IRS rate; preach one or two times / month with preaching stipend (\$250 First Dickson, \$125 Ellis Grove).

#### Evelyn Graham / Southminster Presbyterian Church, Nashville

The Committee on Ministry examined Evelyn Graham, a candidate under care of the Presbytery of Cincinnati, who has accepted a call as part time designated pastor, for two years, for Southminster Presbyterian Church, Nashville. A copy of her statement of faith and autobiographical statement was provided with the COM's report. The COM recommended that Ms. Graham be examined for ordination and installation. The COM approved the following terms of call: Salary \$13,488; Housing \$8,992; Social Security \$1,686; Board of Pensions \$8,205; professional expenses \$1,250; total \$33,621.

Ms. Graham preached, and the Moderator offered a prayer. Ms. Graham spoke of her faith journey, responded to questions from The Rev. Dr. Guy Griffith, chair of the COM Examinations Task Force, and responded to questions from commissioners. Dr. Griffith escorted Ms. Graham out of the sanctuary.

Ms. Denton moved that Ms. Graham's sermon be sustained, and the motion was seconded and approved. Ms. Denton moved that Ms. Graham's examination be sustained, and that she be approved for ordination and installation as part time designated pastor at Southminster Presbyterian Church. There were questions for clarification regarding the two pastoral positions at Southminster. Rev. Durnell explained these were two separate calls – Rev. McCaw is called to be the organizing pastor of a new worshipping community under the guidance of the session of Southminster, and this is a full time call. He explained that Ms. Graham will be pastor of the Southminster congregation, and head of staff. After questions, the motion was approved.

Dr. Griffith and Ms. Graham were welcomed back into the sanctuary, and the Moderator reported on the vote.

The following commission to ordain and install was approved as presented: Saturday, August 19, 2017, 3pm; Teaching Elders - Dr. Elizabeth Caldwell (Honorably Retired), chair; Rev. Jane Herring (Normandy); Rev. Heidi Hudnut-Beumler (Westminster Nashville); Ruling Elders - Mike Brown (Second); Jannette Chambers, Southminster; Thomas Graham (Westminster Nashville); Guests – Rev. Anne H.K. Apple (Presbytery of Mid-South); Lesa Blackwell (Second Nashville); Rev. Raye Nell Dyer (Alliance of Baptists); Rev. Cathy Hoop (Presbytery of Sheppards and Lapsley); Heidi Knellinger (Knox Presbyterian Church, Cincinnati, OH). Persons present in support of Ms. Graham were recognized while she signed the *Book of Ministerial Obligations*.

The Rev. Dr. Cindy Schwartz / Priest Lake Presbyterian Church, Nashville

The COM examined The Rev. Dr. Cindy Schwartz, a minister member of the Evangelical Presbyterian Church, who has accepted a call as pastor of Priest Lake Presbyterian Church, Nashville. A copy of Dr. Schwartz's statement of faith and autobiographical statement was included with the COM's report. The COM recommended that Dr. Schwartz's examination be sustained, and that her transfer back into the Presbyterian Church (U.S.A.) be approved. The COM approved Dr. Schwartz moving onto the field July 1, 2017, and approved the following terms of call: Effective Salary \$54,000; automobile expenses \$2,000; professional expenses \$2,000 (continuing education, books, personal business expenses); four weeks vacation annually; two weeks continuing education annually.

Dr. Schwartz spoke of her call to ministry, her candidacy through the Presbyterian Church (U.S.A.), her call to a church that chose to leave the PCUSA, and her subsequent journey back. Dr. Schwartz responded to questions from Dr. Griffith, and from commissioners. Dr. Griffith and Dr. Schwartz were escorted from the sanctuary.

Ms. Denton moved the examination be sustained, and that Dr. Schwartz be transferred and received back into the Presbyterian Church (U.S.A.). The motion was seconded and approved.

Dr. Schwartz was escorted back into the sanctuary, and the Moderator reported on the vote. Persons present in support of Dr. Schwartz were recognized while she signed the *Book of Ministerial Obligations*.

The motion was made, seconded, and approved to allow the Committee on Ministry to approve the commission to install.

Amy Harkness / Glencliff Presbyterian Church, Nashville

The COM sustained the examination of Ruling Elder Amy Harkness, a member of The Downtown Presbyterian Church, Nashville, and recommended she be commissioned to pastoral service at Glencliff Presbyterian Church, Nashville, for the period July 1, 2017 – June 30, 2018, to moderate the session, celebrate the sacraments, and have a voice and vote at presbytery. A copy of her statement of faith and biographical information was provided with the COM's report. The COM approved the terms as follows: salary \$1200/month (\$14,400/year); automobile expenses reimbursed by voucher at current IRS rate; 40 Sundays during 12 month contract, one Sunday off per month (total of 12 Sundays off).

Ms. Harkness spoke of her faith journey and responded to questions from commissioners. Dr. Griffith and Ms. Harkness left the sanctuary. Ms. Denton moved that Ms. Harkness be commissioned to Glencliff, and the motion was approved. Dr. Griffith and Ms. Harkness were invited back into the sanctuary and the Moderator reported on the vote.

Andrew Smith / First United Presbyterian Church, Sparta and Blue Spring Presbyterian Church, Sparta

The Committee on Ministry sustained the examination of Ruling Elder Andrew Smith, a member of First Presbyterian Church, Cookeville, and recommended he be commissioned to pastoral service at First United Presbyterian Church and Blue Spring Presbyterian Church, Sparta, for the period August 1, 2017 – July 31, 2018, to moderate the session, celebrate the sacraments, and have a voice and vote at presbytery. A copy of his statement of faith and biographical information was provided with the COM report. The COM approved the terms as follows: salary \$250/week (\$13,000 annually); two weeks vacation; one week study leave; mileage at current IRS rate to visit sick in Nashville, Knoxville, Chattanooga; Additional \$100 / services conducted on Christian holidays beyond regular worship (i.e., Thanksgiving, Christmas Eve, Easter Sunrise).

Mr. Smith spoke of his faith journey and responded to questions from commissioners. Dr. Griffith and Mr. Smith left the sanctuary. Ms. Denton moved that Mr. Smith be commissioned to First United and Blue Spring, and the motion was approved. Dr. Griffith and Mr. Smith were invited back into the sanctuary and the Moderator reported on the vote.

### Will Radford / The Village Church

The Committee on Ministry sustained the examination of Ruling Elder Will Radford, a member of The Village Church, Nashville, and recommended he be commissioned to pastoral service at The Village Church, for the period August 1, 2017 – July 30, 2018, to moderate the session, celebrate the sacraments, perform a service of Christian marriage, and have a voice and vote at presbytery. A copy of his statement of faith and biographical information was provided with the COM's report. The COM recommended approval of the following terms: salary \$400/month (\$4,800 annually).

Mr. Radford spoke of his faith journey and responded to questions from commissioners. Dr. Griffith and Mr. Radford left the sanctuary. Ms. Denton moved that Mr. Radford be commissioned to The Village Church, for the terms stated, and the motion was approved. Dr. Griffith and Mr. Radford were invited back into the sanctuary and the Moderator reported on the vote.

The Moderator propounded the constitutional questions to Ms. Harkness, Mr. Smith, and Mr. Radford, and all were answered in the affirmative. There was applause for all three commissioned ruling elders, and persons present in support of each were recognized and welcomed.

The Moderator asked for a ten minute recess.

The meeting was called back to order by the Moderator.

### Recognition of Retirements

The Moderator called on Rev. Durnell to recognize the retirements of teaching elders recently retired. Six teaching elders have been granted the status of Honorably Retired, and three were present at the meeting. Rev. Durnell moved that the resolutions for The Rev. Linda Bray, The Rev. Amelia Canon, and The Rev. Megan Knox Ritchie be spread upon the minutes, and this was seconded and approved without objection.

### **RESOLUTION IN RECOGNITION OF MINISTRY**

#### **THE REVEREND LINDA BRAY**

WHEREAS, The Reverend Linda Bray, a native of Cleveland, Tennessee, was surrounded by the love and security of a large family, and the church, Big Springs Baptist Church, was central to her life for many years even though she always had questions about God; and

WHEREAS, Linda Bray left the church for about ten years following her college years, but never abandoned her search for a deeper understanding of her faith; and

WHEREAS, Linda married and moved to Louisville, Kentucky, on the heels of what she describes as "a deeply moving spiritual experience," she and her husband joined the Strathmoor Presbyterian Church, where she fell in love with Jesus Christ all over again; and

WHEREAS, Linda began to see possibilities as a woman in service to Christ and the church, as she taught Sunday School, lead Bible Studies, was elected and ordained a ruling elder, and felt "called" to serve God in a different way; and

**RESOLUTION IN RECOGNITION OF MINISTRY  
THE REVEREND DR. SAMUEL MORGAN COOPER, IV**

WHEREAS, the Reverend Dr. Samuel Morgan Cooper, IV, was born to Deputy Sheriff Samuel Morgan Cooper, III and Vernice Yates Cooper on January 22, 1951 in the town of Ninety Six, South Carolina, surrounded by four generations of extended family; and

WHEREAS, the Cooper family moved to Greenwood, South Carolina, when Sam was a young boy, where his mother and then his father became involved in the organizing of a Southern Baptist Church in a little country store; and

WHEREAS, Sam Cooper made a profession of faith at the age of 9 and was baptized at another Baptist church, along with his best friend at the time, admitting that there wasn't anything particularly religious about the experience, it just seemed the thing to do; and

WHEREAS, the church became a second home for young Sam, doing most everything there was to do around the church, including cutting the grass on its two acres of property, but he did not miss out on his share of mischief in middle and high school, which was ironic because his father had become the local jailer; and

WHEREAS, Sam, after high school, went to Erskine College, a school of the Associate Reformed Presbyterian Church, in Due West, South Carolina, where he majored in history and served as secretary and then president of the student body; and

WHEREAS, Sam's career aspiration initially was to become a lawyer, but the summer of his senior year at Erskine he decided to go to seminary, having been persuaded by Don Stevenson, a part-time philosophy professor who was also a local Baptist Church pastor to give it a try; and

WHEREAS, after graduating from Erskine in 1972, Sam headed to Princeton Theological Seminary, became a Presbyterian, although still undecided as to whether Christian ministry was "the call" upon his life or not;

WHEREAS, after dropping out of seminary for a year in order to discern whether or not ministry was for him, Sam returned to Princeton Seminary, graduated, completed preparation for ministry in Pee Dee Presbytery, and was called to serve as Pastor for a pair of yoked churches, Carolina and Clio, in rural Marlboro and Dillon counties in northeastern, South Carolina; and

WHEREAS, inside a month of his ordination, Sam married Lily Patterson, a daughter of the manse, who he had been wooing for four years, and her father, the late Palmer Patterson, became a mentor for Sam in his early years of ordained ministry; and

WHEREAS, Sam left the pastorate to become Chaplain (and to coach soccer) at Presbyterian College in the fall of 1979 and moved to Clinton, South Carolina along with their first born child, Samuel Morgan Cooper, V; and

WHEREAS, while at Presbyterian College, Sam had the privilege of serving two small rural congregations and his family grew by two – Palmer Patterson Cooper and Vernon Robinson Cooper were born; and

WHEREAS, Sam left Presbyterian College to accept a call to the Bethel Presbyterian Church in Walterboro, South Carolina, where he and a friend built a house from scratch and tended a large garden along with raising cattle and chickens, and still finding time to complete a Doctor of Ministry Degree at Columbia Theological Seminary in Decatur, Georgia; and

WHEREAS, while serving the Bethel congregation and community, Sam was organizer and first board chair of the Colleton Habitat for Humanity, served the Presbytery of Charleston-Atlantic on the Committee on Ministry, chaired the Congregational Development Ministry Unit, and Committee on Preparation for Ministry, was a Commissioner to the General Assembly, and Moderator of Presbytery; and

WHEREAS, in late 1994, Sam was called to serve as a presbytery leader for a presbytery newly formed by the merger of former Pee Dee Presbytery and Harmony Presbytery, half of the former Atlantic Presbytery and a small portion of the former Fairfield-McClelland Presbytery, with one-fourth of the churches in this new presbytery being predominately African-American; and
